# **BOARD OF DIRECTORS**

Legal Services of Southern Missouri's (LSSM) Board composition is regulated by 45 CFR §1607. Our governing body must reasonably reflect the interests of eligible clients and be made up of members who are supportive of the Legal Services Corporation Act. They must have an interest in, and knowledge of, the delivery of quality legal services to the poor. The Board must have at least 60 percent attorney members. A majority of the Board are appointed by The Missouri Bar. At least one-third of the Board must be client members. These individuals must be eligible to be LSSM clients and are appointed by a variety of groups designated by LSSM.

# MESSAGE FROM THE EXECUTIVE DIRECTOR



Dear Friends,

The year 2020 was a year like no other. As the coronavirus moved quickly across southern Missouri, Legal Services of Southern Missouri (LSSM) was forced to quickly adapt to this fast-changing reality.

The move from closing offices to working remotely also meant a suspension of walk-in traffic and a shift to Zoom, telephone and web-based work. It also meant that LSSM's community education and outreach programs were put on hold. In a matter of weeks, it became apparent that our client community was growing quickly. Calls for our legal help would not just be from families long involved in poverty; we saw many more southern Missouri families needing our help and would be eligible for our services for the first time.

While I saw unprecedented demand and enormous challenges, I saw our staff and volunteers rise to meet the demand for services. I saw our staff transform and learn how to have thousands of phone calls ring from house to house so we could continue providing services from home. When courts closed except for emergency matters, our staff shifted its work and stepped up to handle those emergency cases to ensure access to justice. We learned how to practice law virtually, checking on and communicating with our clients through every remote platform available.

The impact of COVID-19 on LSSM and its staff rolled through our organization like a spring tornado. Fortunately, LSSM's experienced and talented staff were more than up to the task. Our funders remained faithful, and our partners remained true. As COVID-19 challenged us, we worked hard providing quality legal aid to many clients, making positive and meaningful differences in their lives.

To our friends and supporters, thank you! By contributing this past year, you allowed us to do what we do. By volunteering, you helped us expand our services. By collaborating with us you helped change our community for the good. Together we are making a difference!

# CLIENT STORIES

**C** arah is a breast cancer survivor with **D**reconstructive surgery with implants who Legal Services of Southern Missouri (LSSM) assisted in obtaining Medicaid benefits. A few years after her cancer, she started becoming ill, being fatigued, gaining weight and losing hair until she could no longer work. Her cancer had not returned, and doctors could not find out what was wrong. They suspected breast implants, but Sarah did not have insurance to pay for specialists. Sarah had been denied Medicaid several times before. LSSM assisted Sarah with a new Medicaid application working with her medical providers at Jorden Valley in obtaining additional medical records and letters explaining her need for Medicaid. Finally, she was approved and is starting to receive the care she needs.





Maria's eight-year-old autistic son was found to be disabled by the Social Security Administration (SSA) in 2014. Years later, the SSA notified Maria that the disability benefits would terminate because of the child's medical improvement. Maria contacted Legal Services of Southern Missouri (LSSM) for help because the child's autism and ADHD greatly limited his abilities. LSSM helped Maria gather the necessary evidence to convince SSA that her son's disability benefits should continue.

# CLIENT STORIES



om was referred to Legal Services of Southern Missouri (LSSM) by Career Services at the Missouri Career Center. Tom had a suspended driver's license for a period of ten years from a 2012 DUI Felony conviction. Tom had been living with a suspended driver's license for five years and thought nothing could be done. Tom had served his time, had been sober for several years and wanted to work and contribute to society. He took care of his parents who drove but were very elderly. LSSM assisted Tom in obtaining limited driving privileges. Tom was required to have an ignition interlock installed and obtained limited driving privileges which included driving for employment/education purposes, medical/recovery reasons and to drive his elderly parents to medical appointments and to shop for their daily necessities.





Kathryn had been in a very controlling and physically abusive marriage. Throughout the marriage, her husband had strangled her on more than one occasion, beat her, and threw objects at her. He also threatened to kill her. The abuse sent Kathryn to the hospital and law enforcement referred her to LSSM. LSSM helped Kathryn obtain a Full Order of Protection against her husband, and represented her in an Adult Order of Protection action filed in retaliation by her husband against Kathryn, which was ultimately dismissed. LSSM also provided Kathryn an attorney to represent her in a Dissolution of Marriage action, so she can be free of her husband for good.



# **VOLUNTEER LAWYERS PROJECT**

Legal Services of Southern Missouri's (LSSM) Volunteer Lawyers Project (VLP) worked towards fulfilling the goals and objectives as set forth in LSSM's Private Attorney Involvement (PAI) Plan. The VLP focused on recruitment and retention of volunteer lawyers and at the end of 2020, there were 354 southern Missouri lawyers available for volunteer legal services.



- 1. Help 2,499 or less than 1% of the 260,653 poor persons in the service area; and
